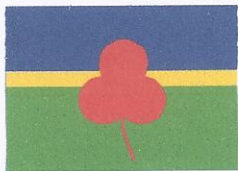
"Constitution of the freeman of Wonderland"

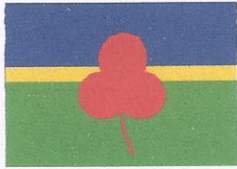


"Parliament of the freemen of Wonderland":

The people, involved in the foundation of the sovereign state of Wonderland have chosen to regard all the inhabitants and residents as the highest authority in the parliament with unlimited participation and decision-making.

In the day-to-day business this highest authority will be represented by a circle of a maximum of five chosen wise freemen (circle of wise freemen). They are being advised by a maximum of seven chosen free practitioners, with a subtask for the implementation of decisions of all the people.

"The people of Wonderland"

The people of Wonderland can be subdivided in three variants:

- 1) Inhabitants: people, whether or not in possession of a Natural Person, who physically settle on the land or intend to do so within a term of 365 days after application/notification .*
- 2) Residents: people who settle their Natural Person in Wonderland and physically stay elsewhere.*
- 3) Elderswoners (untransl.): people who, because of personal circumstances and considerations, do not chose to settle physically nor their Natural Person in Wonderland. They undertake, in heart and mind with the principles and ideals of Wonderland and use, whenever possible, provisions in Wonderland.*
